## **GEORGIA KESTOL, PRESERVATIONIST**

While Georgia Kestol is best known as a preservationist, owner and restorer of the Heart Prairie Norwegian American Methodist Episcopal Church located near Whitewater Lake on County P, she also possesses letters from the Civil War. The church, built in the 1850's and its restoration is her passion. Kestol lives on the family homestead farm her great, great grandfather built on Territorial Road. Peder and Anna Kjostolson, who shortened their name to Kestol are her ancestors. Not only did she acquire the church because of this association, but in the family homestead she found a treasure trove of materials that the family had for generations. There were stacks of letters from relatives describing immigrant life from farming to letters sent from the Civil War front by Jesse Kjostolson. Another letter in the collection discusses the untimely assassination of Abraham Lincoln. Further items were a vast collection of historic photos which also included those of Civil War soldiers. Kestol, pictured below will be the guest speaker at our



June meeting where she will share her family history and Civil War letters. It will be a unique opportunity to experience the Civil War through the eyes of a voung Norwegian soldier from Walworth County. Join us for an interesting evening as Kestol shares history.



### IRON BRIGADE MEMORIAL HIGHWAY PLAQUE

In the March newsletter, it was reported that the Col. Hans C Heg Camp #15 plans to erect a plaque commemorating the Civil War service of the Iron Brigade. We are happy to report that the ceremony for installation of this plaque will take place on July 14<sup>th</sup> at 10:00 am in Sauk City, WI. The plaque will be installed at Veterans Memorial Park along U.S. Highway 12 at 10:00 am. The total cost of the bronze plaque was \$2,328.00. Camp #15 was able to obtain a grant from the National Sons of Union Veterans of the Civil War (SUVCW) in the amount of \$1,878. The Wisconsin Department of the SUVCW donated \$500 and private donations completed the project. Tent #23 has been invited to participate in this event which is a "fitting tribute to the men of the five regiments of the Iron Brigade who sacrificed so much to preserve the freedoms and liberties we enjoy as Americans today".
