HISTORY OF DELAVAN G.A.R. MEMBERSHIP BADGE DISCOVERED

An incredible journey began this fall when Franklin Stoneburner, a Delavan historian, showed Pat Blackmer a G.A.R. membership badge from the George H. Thomas, Post #6 of Delavan in virtual mint condition. The badge would have been worn to meetings and in parades, and the reverse side would have been worn to honor the deaths of Civil War comrades at their funerals. Franklin did not know who the owner had been, but told Pat he had purchased it at an auction in the late 1950's from the Robert T. Seymour estate on Racine Street in Delavan.

Intrigued, Pat offered to assist in identifying the owner and embarked on a s search to find him. Robert's father, father-in-law, and other relatives were ruled out.

His mother, however, had resided at the Racine Street address with Robert and his wife, and upon further investtigation, Pat discovered that she was no longer a Seymour. She had gotten remarried to John Richard Brabazon in 1894. Upon checking Delavan and the state of Wisconsin Civil War records, a soldier by his name was found.

John Brabazon was born in 1843 in Canada near Niagara Falls, and his family moved to the Delavan area in 1857. When the Civil War broke out, he enlisted in Co. E of the 28th Wisconsin Volunteer Infantry on Aug. 21, 1862. He was discharged from Union service on Aug.

23, 1865. Following his service, he settled in Sugar Creek for 16 years before moving to Delavan where he raised poultry and developed several businesses. He served on the Delavan city council for many years, and was a member of numerous clubs and organizations. At the time of his death on Jan. 24, 1917 he was commander of the Delavan G.A.R. He is buried in Spring Grove Cemetery in Delavan. His grave site no longer has a G.A.R. marker, so Tent #23 will honor his service by installing one there.

In John's obituary, his stepson, Robert Seymour, was mentioned. Robert must have inherited John's badge when his mother passed away. Franklin Stoneburner has graciously decided to share this piece of history by donating it to the Delavan Historical Society. Tent #23 has purchased an archival display box for the badge.






